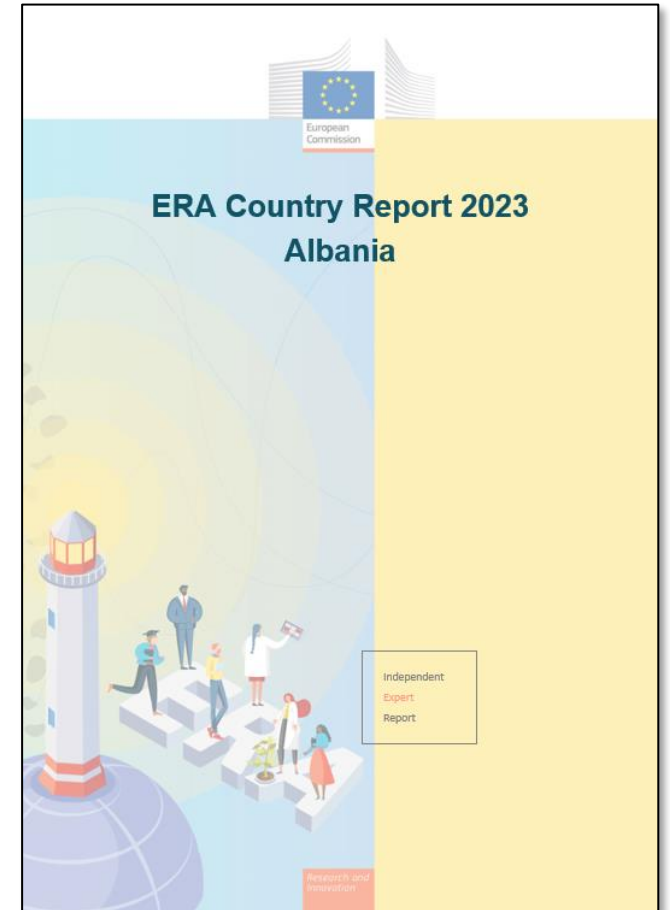
Albania's ERA integration - selected highlights

- Albania is progressing towards priorities of the ERA Policy Agenda 2022-2024; no formal commitment to the priorities yet
- Key initiatives:
 - New Draft Law of Science (in preparation) includes the topics: Open Science, research infrastructures and knowledge valorisation
 - Opening of the EURAXESS Portal
 - EIT Raw Materials KIC centre to be opened soon
- Participation in the European Innovation Scoreboard and the She figures report



Albania's ERA integration - selected recommendations

- Enhance R&I funding to better implement strategies, laws, and measures regarding R&I
- Improve professionalisation of research management to foster participation of Albanian researchers in international projects and the ERA



Bosnia and Herzegovina's ERA integration - selected highlights

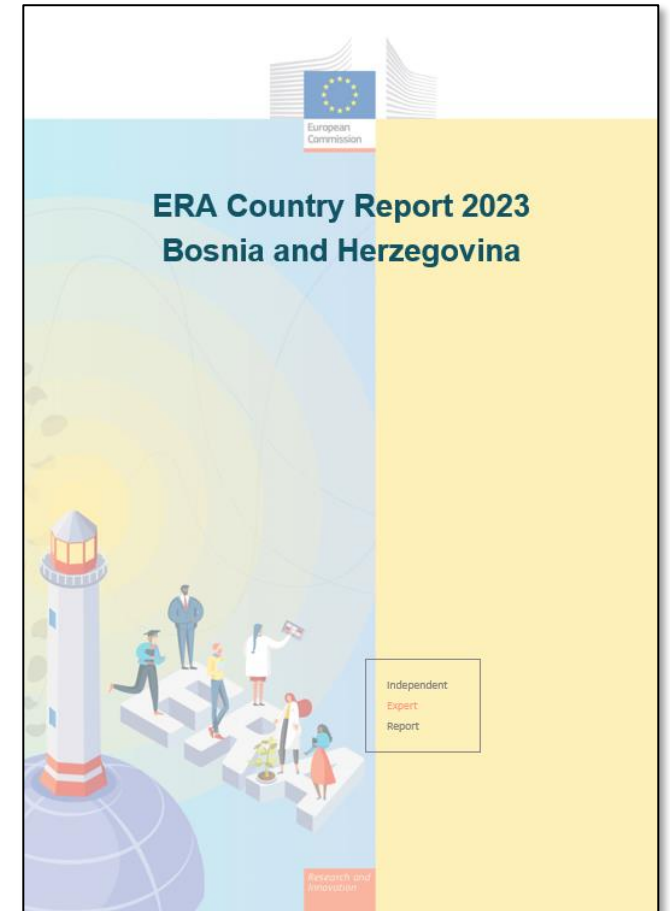
- Progress regarding the implementation of ERA priorities: Open Science, gender equality, promotion of attractive research careers, international cooperation, research infrastructures
- Increased success in Horizon Europe: University of Sarajevo (UNSA) as project coordinator; University Clinical Centre of the Republic of Srpska partner institution under EU Cancer Mission



Horizon Europe project with UNSA as first project coordinator from BiH

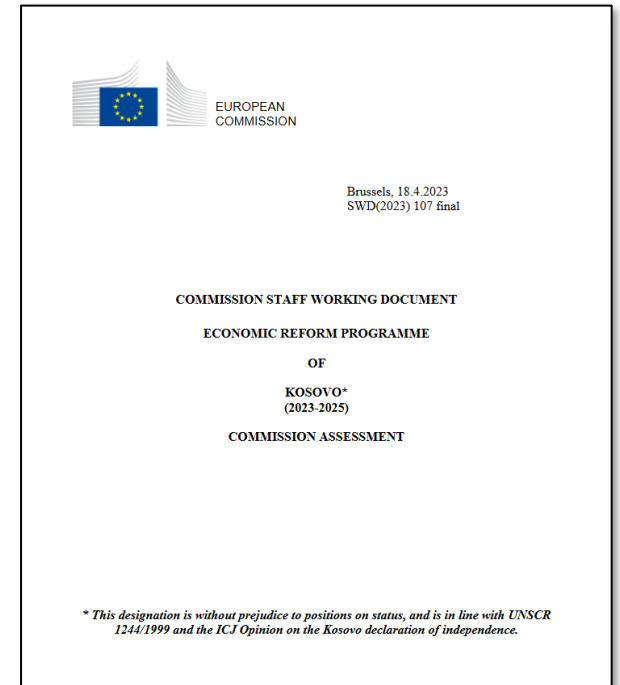
Bosnia and Herzegovina's ERA integration - selected recommendations

- Further implement priorities of the ERA Policy Agenda
- Make the development process of the Smart Specialisation Strategy more effective
- Make use of the increasing interest of researchers in European programmes and foster their participation



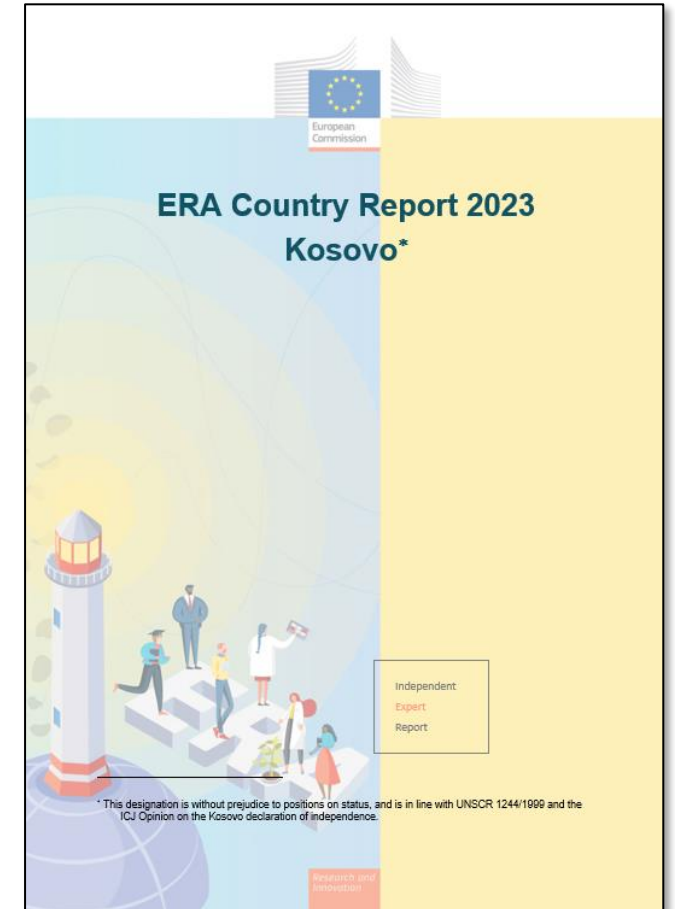
Kosovo's ERA integration - selected highlights

- Gradual progress in aligning with the ERA priorities
- National Research Programme 2023-2028: new opportunities to foster R&I (research excellence, internationalisation, Open Science)
- Increasing participation of researchers in European R&I programmes



Kosovo's ERA integration - selected recommendations

- Align the R&I legal and policy framework to the ERA Policy Agenda
- Further develop the Smart Specialisation Strategy
- Provide more incentives for R&I actors to collaborate nationally and internationally



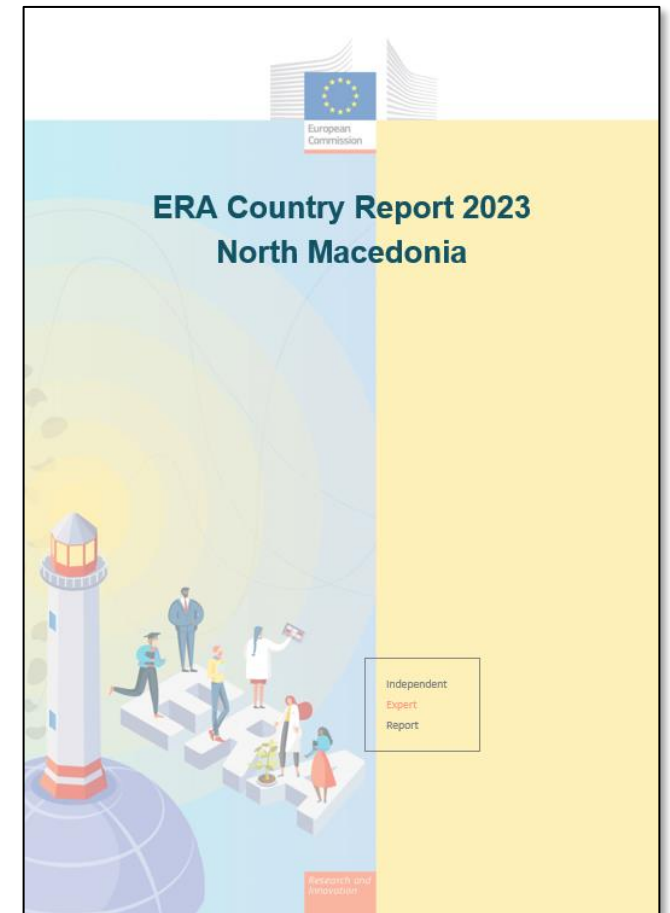
North Macedonia's ERA integration - selected highlights

- Formal commitment to six ERA Actions under three priority areas of the ERA Policy Agenda in September 2023
- First EIT Innovation Hub launched at the Centre for Technology Transfer and Innovation in Skopje in June 2023
- Development of the Smart Specialisation Strategy is in its final stage



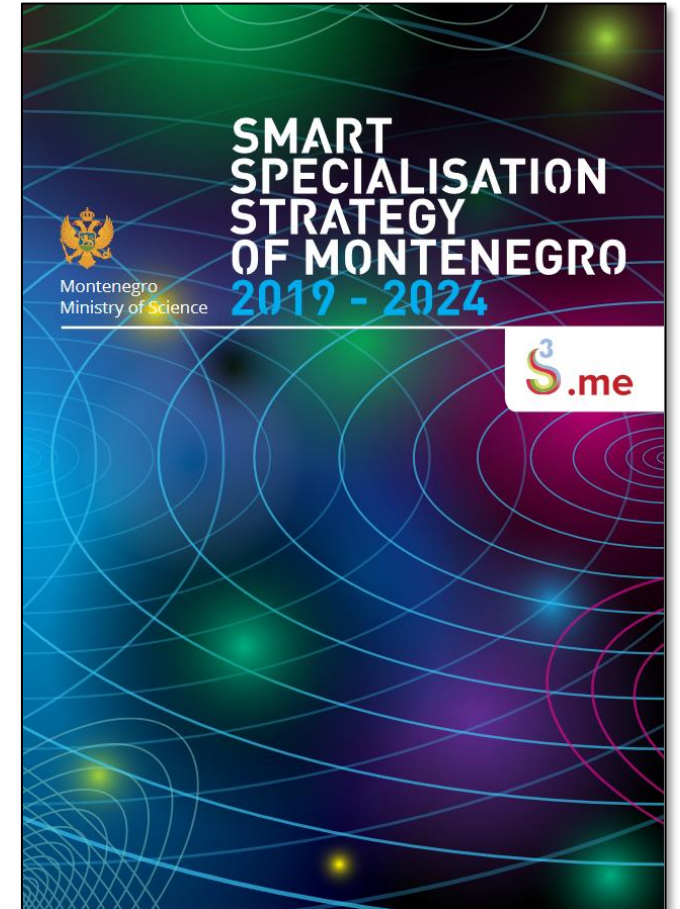
North Macedonia's ERA integration - selected recommendations

- Improve the implementation of key strategies, programmes and priorities to more efficiently use R&I funds
- Enhance funding from both the public and private sector to develop a knowledge-based society through Green and Digital Transition



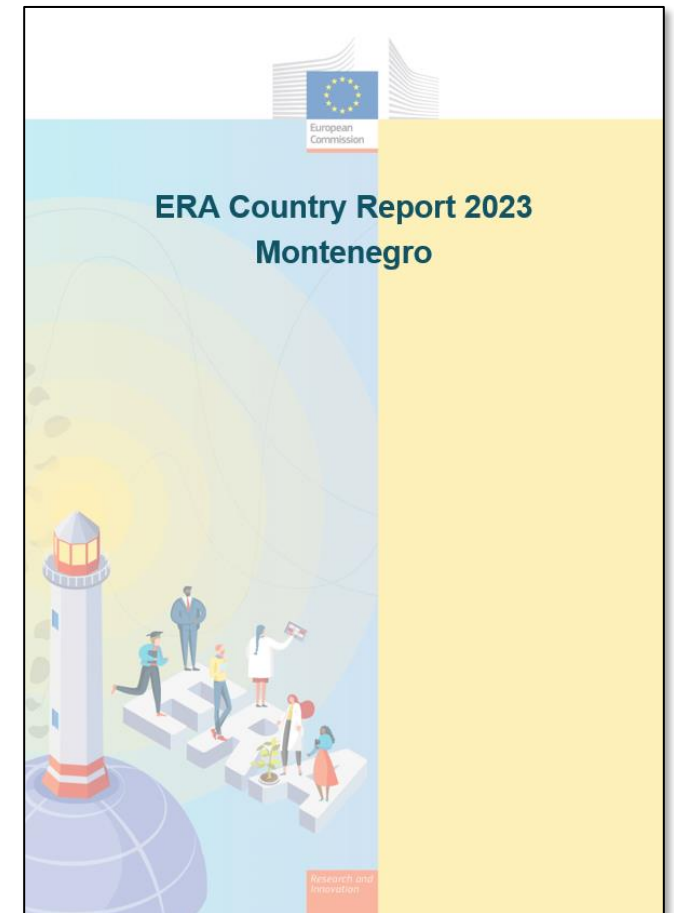
Montenegro's ERA integration - selected highlights

- Implementation of the ERA Policy Agenda through several initiatives; determination by internal capacities to reform the R&I system and mobilise resources
- Integration of the ERA priorities in the draft National Strategy for Research Activities (2023-2027)
- Smart Specialisation Strategy 2019-2024: role model for the cooperation of different actors and for the strengthening of the academia-business cooperation and knowledge transfer



Montenegro's ERA integration - selected recommendations

- Facilitate stronger integration into the ERA by securing additional domestic and international sources; thus foster the sustainability of R&I reforms and the development of the R&I system
- Improve science-industry cooperation through higher investments by the public and private sector



Serbia's ERA integration - selected highlights

- Advancements towards the ERA Policy Agenda: Open Science; gender equality; no formal commitment to any ERA actions
- Integration into ERA through institutional funding reforms and introduction of policy measures; creation of a favourable environment for R&I and science-industry cooperation
- Establishment of a system for the further development of deep-tech: Law on Digital Assets, tax incentive schemes for high-tech companies, PhD programmes on Artificial Intelligence
- Increase in the innovation performance according to the European Innovation Scoreboard



Serbia's ERA integration - selected recommendations

- Enhance R&I funding to further implement the ERA Policy Agenda
- Work on enacting the European Research Infrastructure Consortium Regulation into national law
- Improve the efficiency when implementing strategic policy documents and action plans (such as the Smart Specialisation Strategy)



Future POLICY ANSWERS activities on ERA reporting

- POLICY ANSWERS will prepare the yearly updates of the WB ERA Country Reports; based on the template by the European Commission
- A workshop on ERA reporting is planned for the next physical Steering Platform Meeting at the beginning of June 2024
