
BIOEAST Initiative



Central and East European (CEE) Initiative

- International cooperation led by agricultural ministries (since 2016)
- Members: 11 CEE countries
- Main activity: identification of specific
 CEE research and innovation priorities
 for bioeconomy development,
 recommendations for actions
- Ambition: stronger and more successful participation in the EU R&I Framework Programme

BIOEAST Initiative - Achievements

Better visibility

The BIOEAST is mentioned by the EU Bioeconomy Strategy and by 3 Council Conclusions: 2019, 2020 and 2023.

Clear influence on Horizon calls

Central and Eastern Europe is slowly becoming focal area within the EU research and innovation framework program: Horizon Europe Cluster 6 and the Circular Bio-based Europe Joint Undertaking acknowledge the macro-region's distinct climatic zones as critical issues to be addressed.

More active international networking

European level bioeconomy related events regularly invite the BIOEAST initiative to participate and represent the macro-region.

Message to deliver

The biomass produced and processed locally in Eastern Europe, along with the available soil and freshwater resources and ecosystem services, can be key elements for ensuring the security of a sustainable European food system, as well as Europe's autonomy in a multipolar world.

For a better utilization of this potential, the Eastern macroregion needs to have:

- knowledge transfer, research and innovation investments
- efficient research funding structure
- human resource mobilization

These goals could be best achieved by setting up a targeted R&I-driven partnership (total budget 400 million EUR) with a clear and strong focus on BIOEAST countries, WB, UA, MD.

Priorities for Hungarian EU presidency

Based on BIOEAST as a valid platform for preparation of the future R&I partnership, the Hungarian EU presidency sets itself the goals

- to agree on the necessity of a large-scale macro-regional R&I-driven partnership, aiming to make this partnership a priority for the new Commission
- to agree on involvement of neighbouring countries along the BIOEAST and Danube Strategy Region alliances: Western-Balkan, Eastern Partnership
- to agree on the four thematic priorities related to soil, freshwater, food system, and biomass valorisation at local level
