Focusing on research and innovation (R&I) policy and governance systems, the project also addresses related areas in education, culture, youth, and sports as well as priorities such as green, digital and health.


POLICY ANSWERS monitors and promotes policy coordination within the European Union (EU)-WB cooperation, supporting the six WB economies: Albania, Bosnia and Herzegovina, Kosovo\*, Montenegro, North Macedonia and Serbia. It works to enhance their potential for successful participation in regional and multilateral activities, fostering cooperation and increasing access to networks, information and excellence in the abovementioned areas.

Monitoring the Implementation of the WB Agenda

A set of indicators was developed, leading to the creation of Monitoring Cards for six key areas with a first baseline monitoring in 2023. This framework has been further developed for the latest edition of the Monitoring Cards in 2024. The six key areas are: Research and Innovation; Education; Youth, Culture, and Sport; Digital; Environment; Common Regional Market.

Monitoring and Analysing the WB ERA Integration

Two editions of ERA reports have been drafted with the help of experts from the WB in 2023 for all six WB economies and in 2024 for Albania, Bosnia and Herzegovina, Kosovo and North Macedonia. Selected results of these reports were published in the ERA Cards (2023) and an ERA Fact Sheet. (2024). Further highlights of the activities regarding WB ERA integration were an ERA Workshop in Skopje in June 2024 on the occasion of the WB Steering Platforms and a POLICY ANSWERS webinar that dealt with the implementation of ERA in the WB.

- Strengthening the R&I Community and Promoting Joint R&I Actions Foresight exercises at a workshop in Podgorica in June 2023 facilitated a discussion with key experts from the region on anticipatory science advice and foresight. The results were summarised in Foresight Card to support future actions and served as an input to further discussions back-to-back at the Ministerial meeting in Skopje in September 2024.
- Policy Input for the Upcoming EU Framework Programme for Research and Innovation (FP10) A Policy Brief was issued, offering input from a Western Balkans perspective and supporting the region's economies in enhancing their participation in the in multinational research and innovation programmes.


## Regional Pilot Activities

**POLICY ANSWERS** 



The POLICY ANSWERS Pilot Programmes support tangible change and enhance impact across the WB. These regional pilot activities directly engage academia, industry and civil society, fostering new initiatives and success stories at the programme level.

- The <u>WB Mobility Scheme</u> provides grants to early-career researchers from WB economies
  for research stays in other WB economies. With a call budget of EUR 100,000, it will fund 22
  projects, selected out of 31 applications submitted to the pilot call.
- The <u>WB Innovation Vouchers</u> are financial incentives designed to facilitate partnerships and knowledge exchange between small and medium-sized enterprises (SMEs) and public research institutions across the Western Balkans.
- Under the <u>Regional Promoter Scheme for Research Infrastructures</u>, five Research Infrastructure Ambassadors have been appointed for the Western Balkans.
- The <u>Regional Innovation Academy</u> platform has been established and is currently in its testing phase.



#### **Regional promoter** scheme for Research Infrastructures














## Western Balkans Info Hub and Communication

## Project Management





The project fosters a strong culture of cooperation, ensuring open communication and exchange among 14 partners from across the region. These partners represent a diverse range of stakeholder types, including funding agencies, universities, public and private research institutes, science and technology parks and SMEs. All activities are implemented collaboratively by this diverse group, both within and beyond the WB region, working closely with the European Commission (EC), the Regional Cooperation Council (RCC) and other stakeholders engaged through the Project Advisory Board (PAB).

The Western Balkans Info Hub, a key initiative of the project, has been recognised as a <u>flagship under the EU Strategy for the</u> <u>Danube Region</u>, further enhancing its strategic importance. Project management ensures effective administrative, financial and technical coordination within the partnership and with the EC. This coordination aims to support policy alignment and foster dialogue between the EU and the WB, reinforcing the impact of the project's activities.


