BACKGROUND

To build up on our efforts to strengthen mobility-driven research and innovation in the region, as a result of the achievements within the <u>Mobility thematic working group</u> that <u>SCIDEV</u> led in 2023, within <u>Civil Society and Think Tank Forum 2023 (CSF2023)</u> of the <u>Berlin Process</u>, we are implementing a follow-up project dedicated to enhancing mobility-driven research and innovation in the Western Balkans (WB6) for sustained economic growth and convergence with the European Union (EU), supported by the <u>Open Society Foundations - Western Balkans (OSF-WB)</u>.

The <u>"Enhancing Mobility-Driven Research and Innovation in Western Balkans For Sustained Economic Growth and Convergence with the European Union"</u> project aims to contribute to the European and regional research and innovation agendas and influence decision-makers to increase investments and create more opportunities for mobility-driven research and innovation (R&I), while contributing to a stronger research and innovation ecosystem across the Western Balkans.

Building synergies with the <u>Joint Science Conference of the Berlin Process</u> and the <u>Chairs' Conclusions of the Leaders' Summit in Tirana in October 2023</u> and using the momentum of the <u>New Growth Plan of the EU for the Western Balkans</u>, SCiDEV continues to contribute to research and dialogue around the region's integration into the European Research Area and sustainable economic development through science, technology, and innovation. This discussion is also framed by the opportunities presented by the EU's New Growth Plan for the Western Balkans, the planning of the new <u>Framework Programme</u> and <u>Competitiveness Fund</u> of the EU and the <u>European Political Community Summit in Tirana</u>.

This event brings together key stakeholders, researchers, and policymakers to reflect on and advance the role of mobility-driven research and innovation in the Western Balkans. It will present key insights from the research work of SCIDEV throughout the project, featuring presentation of the projects' policy briefs, and provide a platform to push forward concrete recommendations to decision makers.
