

## Common Regional Market



The Western Balkans Agenda on Innovation, Research, Education, Culture, Youth and Sport is a long-term strategy from the EU and the Western Balkans (WB) for cooperation with the region. It will contribute to the region’s economic and societal development, building on three main pillars: Political, Thematic, and Regional.

The project POLICY ANSWERS monitors the implementation of the Western Balkans Agenda, and the broader context, progress and achievements are summarised in regular reports. In this Monitoring Card, you find the results of the fourth round of data collection in 2025 and at the beginning of 2026, in comparison to the data collected in the previous third monitoring round.

In terms of Common Regional Market, the monitoring focuses on the context indicator “Exports of goods in other WB economies as percentage of total exports” and various achievements outlined in the WB Agenda (see next page).
